# Midland Concert Band Board of Directors Meeting April 27, 2025

# Review and approve minutes from the last meeting (March 16, 2025)

Beth moved to approve the minutes with no corrections. Dave seconded, and the motion carried.

# Treasurer's Report (Beth)

MCB has received \$5000 from Midland Area Community Foundation to cover four scholarships. All other scholarship funds that we have been expecting have been received. The Pollock scholarship will not be funded by the family this year – it was not an endowed scholarship. We have funds to cover that scholarship for this year. We still need information from scholarship winners regarding where to send their funds.

Leadership at the Alden and Vada Dow Foundation is changing, and the grant process could change next year. We will need to review how we use their grant money and decide whether to apply next year.

Sue moved to approve the Treasurer's report with no corrections. Beth seconded, and the motion was approved.

#### Conductor Reports (Joel/Jacob)

Joel: Concert preparation for next Sunday is going smoothly. He is working on a seating arrangement to help with logistics. He will complete and send concert promo material to Jacob to announce at the Jazz Band concert on May 2.

Jacob: The Jazz Band is set for the concert at the library next Friday. Donations will be accepted at the concert. Preparations for the June 3 concert at the Saginaw Art Museum are in place.

Dave mentioned that band members had raised questions regarding the jazz band including membership/dues status of players, extra rehearsal time affecting MCB participation, and how an upcoming increase in rehearsal space fees would affect MCB's ability to accommodate extra jazz band rehearsals. Further discussion was planned for the next meeting to allow time for clarification.

# **Education Report (Sue)**

Comp tickets have been distributed to 7<sup>th</sup> graders and scholarship winners. Certificates are completed and have been given to directors.
